What is involved in an **All8 Sensory Support** session:

**All8 Sensory Support** offers an opportunity to explore sensory needs through experiential play and activities both in the studio and outside in the countryside. On occasion, it may be possible to interact with animals such as dogs, guinea pigs, sheep and horses but this will not be the primary focus of the session.

Wick Yard is a public space and other members of the public and tenants pass through the farm. Learners will be supervised 1:1 at all times and, although minimal, opportunity for social interactions sometimes occur. These are always supervised by the facilitator. There is the opportunity to utilise local quiet countryside footpaths and lanes, for walking, possibly with a dog accompanying us. Details of these walks are available and have been risk assessed. Again though these are quiet rural routes, interactions with the public may occur.

## **ACKNOWLEDGEMENTS**

I acknowledge that animals can be dangerous and may behave unpredictably or in ways that may cause injury, damage to a persons property, disability or in very extreme cases death. I understand and acknowledge that I may be injured or my personal property may be damaged or destroyed whilst taking part in this activity.
